Policy Description

COVID-19 Code of Conduct

1. Everyone who comes to the Club must first read this document and be ready and equipped to fully abide by its provisions. This is strictly for the current phase of reopening and may evolve as the COVID-19 restrictions evolve.
2. As a member of the club, I agree to the following to help ensure the health and safety of everyone associated with the club.
 - a) In this first phase of opening, **I will only come to the Club in the time slots allocated.**
 - b) **I will not, under any circumstances, come to the Club if I have any symptoms of COVID-19 or if anyone I am living with or have come into contact with has such symptoms.** Please refer to the provincial guide for guidance <https://covid-19.ontario.ca/self-assessment/> (If you have a condition whereby you are immunosuppressed, are in the vulnerable age group or have a chronic illness, you should consult your physician or public health resources to help you decide if you should come to the Club.)
 - c) When at the club, I agree to abide by all government mandated physical distancing measures such as maintaining 2m distance from others and not congregating in groups. I recognize that physical distancing is the greatest tool to keep everyone safe.
 - d) I agree to sanitation measures and using supplies provided to wipe down equipment and/or shared areas as directed by coaches, supervisors, and outlined directives of the club.
 - e) I will not spit or otherwise spray fluids from my mouth or nose into the air, onto the equipment or the ground. I will use a tissue for this purpose and place the tissue in my personal garbage bag for disposal at home.
 - f) To protect others, I will carry a face mask with me and if risk of a situation of becoming near someone occurs, I will ensure my face mask is worn over mouth and nose.
 - If I use a disposable mask and/or gloves, I will place these items in my personal garbage bag for disposal at home.
 - g) When at the Club, I will bring food and water as well as hand sanitizer. Personal belongings will need to be kept together, water bottles etc. should be in a sealed ziploc type bag.
 - I will not bring snacks that require a portion to be spit out, e.g. sunflower seeds.
 - h) No “drinking water” is available at the club; there will be running water available for cleaning.
 - i) I will bring extra bags to take garbage or other items home with me.
 - Garbage cans will not be provided, and the club needs your commitment to keeping the property clear of personal garbage.

Commitment

1. These are not normal circumstances. All members are asked to be flexible and polite and to compromise when necessary.
2. Failure to follow these directives, will include the following steps:
 - I. First incident will include a verbal warning.
 - II. Second incident, individual will be asked to leave the property, current season privileges will be withdrawn, and remaining membership monies will not be refunded.
3. I agree the Club reserves the right to:
 - a) reprimand anyone for not following these directives
 - b) insist that they be followed and
 - c) at the sole discretion of any Director or designate, ask the individual(s) to leave the property.
